Starting bank balance (with subs) was £10K, but most of that has already been spent on free shorts and socks for every player, balls, cones, water bottles, bibs, jerseys for new U12 team, first aid kits, approx. £2.5K will be spent on facility hire and we will need to keep approx. £1.5-2k for CCBC consultation/legal fees/planning fees for possible placement of storage unit to hold all the club's equipment.

Purpose for which assistance is required and estimates of costs:

We have more members joining every year and we have started a Girls U16's team and a third U12's team this year. We therefore need more equipment to ensure the safety of those teams. The rugby union season does not run throughout the summer and Aber Valley Wolves management feel that league keeps the children off the streets, keeps them fit (especially whilst children recover from the pandemic where they couldn't do much sport), helps with their mental health and rugby league occupies their time.

We will be applying to Aber Valley Community Council and Caerphilly Town Council
