**MINUTES OF THE COMMUNITY COUNCIL MEETING  
HELD ON THURSDAY, 16<sup>th</sup> JUNE 2022 AT 7.00 PM  
AT PENYRHEOL COMMUNITY CENTRE**

Eight members of the public were in attendance. A spokesperson for the residents showed Councillors a video of a speeding car with a loud, backfiring exhaust which was causing a noise nuisance to residents in Caledfryn and he said that residents were at their wits' end. The PC in attendance said that they could deal with speeding, but in terms of equipment, they were not trained to check exhausts, but that Traffic police had been informed. The person concerned had already received a Section 59. Police could not seize a car from video evidence. The spokesperson added that he had written to various organisations, including CCBC and the Police Commissioner, but had received no reply. He was advised to ask for a reference number when contacting CCBC and that CCBC's Environmental Health Department had equipment to monitor the noise levels. Councillors could then follow up the issue with a reference number. Residents were also advised to report every incident to the Police, either via 101, Facebook, email etc, as it was important that every incident be recorded. Residents added that the noise levels were not acceptable and that they had had enough. Residents agreed to log and report every incident and County Borough Councillors agreed to then chase up complaints made to CCBC. It was also agreed that the spokesperson would forward the letter sent to the Police Commissioner to the Clerk.

- 2. Spokesperson to forward letter sent to Police Commissioner to Clerk.**
- 3. County Borough Councillors to chase up complaints made to CCBC once reference numbers were obtained.**

Councillors held a two-minute silence for Cllr Bill Allen, who had recently sadly passed away. A Councillor said that Cllr Allen had been a Councillor for many years, had immense stature within the community and had been highly regarded. He would be sorely missed by his family, friends and community. A Councillor added that he was the epitome of a good person living within the wards, who had carried on working for the community to the end. A memorial day would be held on Sunday, 10<sup>th</sup> July to unveil a plaque at Penyrheol Community Centre, where Cllr Allen had been Chair of the Committee and Committee member for many years.

**49. To discuss Police matters**

The PC and CSO reported that no community tension had been reported since the sentencing in the dog attack case. A Councillor said that it was important for the CCTV at the Top Shops to be retained, as it had provided vital evidence in the case. The PC added that it had been key to prosecution showing the behaviour of the dog. Criminal damage had been reported at Pleasant Place, Penyrheol and the Police had urged CCBC to keep the lighting on in old aged pensioners' complexes. Racial incidents at the Top Shops had also been reported and video evidence used. Councillors informed the Police that there had been a story on Facebook about an early-hours knife attack in Penyrheol Park. A Councillor also reported break-ins on St Cenydd Road. The Police added that there was an ongoing drugs issue in Trecenydd, which they were in the process of dealing with.

**50. To discuss items/issues brought up by Councillors**

SD reported that the lane behind Heol Fawr in Penyrheol leading to Bowls Lane was now unpassable, was full of rubbish and was attracting rats. The overgrown trees were also pushing residents' fences down. JS agreed to a site visit with SD.

**51. To receive reports on meeting/events attended by Councillors**

SD reported that she had attended both playscheme registrations, playscheme trip meeting and the Jubilee celebrations at Hendre Junior School. SJS reported that he had attended both playscheme registrations. SLS reported that she had attended both playscheme registrations. JS reported that he had attended the Jubilee celebrations at Hendre Junior School.

**52. To receive verbal reports from Chairs of committees: Playscheme Committee held on 13.06.22:** The Chair of the Committee reported that the Committee had met with playworkers to discuss ideas for trips and equipment needed for the summer playschemes.

**53. To discuss Communications, Website and Social Media**

The Clerk reminded Councillors that the Community Council had to produce an annual report and Councillors agreed to discuss at next meeting.

Councillors agreed that the CIL Working Group needed to meet. LW reported that he would be meeting with two CCBC officers to discuss the possibility of planting shrubs on the banking of Hendredenny Drive. It was agreed that Councillors would chase CCBC officers regarding the dirt track etc.

**55. To discuss Youth Ambassador vacancy**

Councillors agreed that the Clerk should post the advert for the Youth Ambassador vacancy and purchase a £25 voucher as a thank you to the outgoing Youth Ambassador. The advert would be circulated around the secondary schools.

Councillors discussed the application and said that parking in the street was already an issue and volume of traffic would only worsen if more houses were built. There would also be an effect on drains/sewerage. The houses would be built within the garden of an existing house and would not be in keeping with the other dwellings.
