

MINUTES OF THE COMMUNITY COUNCIL MEETING HELD ON THURSDAY, 19th SEPTEMBER 2024 AT 7.00 PM AT PENYRHEOL COMMUNITY CENTRE

The Chair welcomed Councillors to the meeting.

59. To note members' attendance and to receive and approve apologies for absence

Apologies for absence received from ClIrs E Llewellyn and A Minton and apologies accepted.

60. To discuss Police matters

CSO Collins reported an ongoing issue with off-road bikes and advised that local resident intelligence/photographic/video evidence would be welcomed of the bikes being ridden on the highway and where they were being kept. This would enable Gwent Police to seize the vehicles. CSO Collins reported anti-social behaviour/vandalism at St Andrew's Church. Six ASB referrals had been issued. Anti-social behaviour was also an ongoing issue at Pleasant Place. Fires had been started in Penyrheol and Trecenydd. Shoplifting in the area was also an ongoing issue, with Gwent Police carrying out shoplifting patrols. A hand grenade was found in Hendredenny, which had been dealt with safely after evacuation of numerous nearby houses. CSO Collins reported that the CSOs now covered three schools each. She also asked to book Police surgeries.

Cllr Dickens reported an issue with two XL Bullies, which was being dealt with by the Police. CSO Collins requested that residents inform Gwent Police of any issues regarding potentially dangerous dogs/breeds. Cllr Owen reported issues with parking in general on the Penyrheol estate. Cllr SJ Skivens reported on the Top Shop Working Group, which he believed had failed to resolve issues in the area of the Top Shop due to poor engagement from CCBC/Gwent Police. The situation was worsening, with drug use/sale and anti-social behaviour a big problem. Clerk to send CSO Collins minutes of the Working Group meetings. CSO Collins to liaise with her sergeant/inspector to discuss further and to arrange a

Aber Valley FC Foodbank: Cllr Skivens reported that he had met with a representative of the foodbank and had no concerns regarding how it was being run. The foodbank received referrals from social workers, GPs etc and the food parcels were delivered to recipients. The foodbank was not affiliated to the Trussle Trust, but Cllr Skivens had no concerns, as the foodbank did refer recipients to other services. It was resolved that the foodbank would be given a grant of £100 per month for the foreseeable future.

Cllr Dickens reported that she had received a request for financial assistance for a chain link fence around St Andrew's Church due to the recent damage/vandalism. Councillors suggested the Church apply for a grant from the Community Empowerment Fund via the online process.

Cllr Dickens reported overgrown nettles on a path leading to Aneurin Park. Also a dog fouling bin needed replacing.
