MINUTES OF THE COMMUNITY COUNCIL MEETING HELD ON THURSDAY, 17th APRIL 2025 AT 7.00 PM AT PENYRHEOL COMMUNITY CENTRE

The Chair welcomed Councillors to the meeting and informed councillors that Cllr Emma Llewellyn had stepped down as Community Councillor. The Chair wished to thank Cllr Llewellyn for her continued hard work during her term of office and wished her well for the future.

168. To note members' attendance and to receive and approve apologies for absence

PCSO Greedy reported that there had been reports of anti-social behaviour in the Penyrheol area, especially in the grounds of St Andrews Church. Advice had been given to purchase further CCTV and to fix the back fence. It had also been advised to lock the gates when church not in use. Cllr Whittle said that there may be Community Empowerment Funds funding for the back fence.

Cllr Skivens reported the deteriorating anti-social behaviour situation in Penyrheol. Residents were coming forward to councillors. He added that a Top Shop Working Group had been set up but declining attendance by the relevant personnel meant the meetings could not go ahead any longer. PCSO Greedy said that Gwent Police were not receiving calls regarding anti-social behaviour off the public and was informed that residents were scared to come forward with information.

It was agreed that PCSO Greedy would arrange a meeting with Gwent Police's sargent/inspector to discuss the issues in Penyrheol and clerk to get suitable date from Community Councillors.

Cllr Whittle asked about the fact that police officers had allegedly taken a tent off a homeless man and ripped up the tent and was informed that the tent was taken away due to other pending charges but it was not ripped up.
